We host 2-3 cleanups each month, creekside planting days, monthly educational tours, workshops for watershed residents, and we maintain 4 rain gardens that filter water flowing off Shoal Creek Blvd.**4b** (Code:) (Expenses \$ 195,239. including grants of \$) (Revenue \$ 20,000.)Trail Plan: New trail projects also kicked off in 2024, such as the new urban trail between Shoal Creek and North Lamar Blvd near the Gaston Green dog park, as well as the designs for the .7-mile-long trail extension connecting the Shoal Creek Trail to the Red Line Trail and Q2 stadium.**4c** (Code:) (Expenses \$ 120,579. including grants of \$) (Revenue \$ 15,271.)Community Engagement: In 2024, we hosted 54 volunteer workdays with over 750 volunteers who removed nearly 23,000 pounds of litter from Shoal Creek.
