Watershed Action Plan: Shoal Creek Conservancy advocates for improvements to the Shoal Creek Trail, actively cleans Shoal Creek and partners with the community to have a watershed-wide decrease of pollutants entering the creek. We host 2-5 cleanups each month, creekside planting days, monthly educational tours, workshops for watershed residents, and we maintain 4 rain gardens that filter water flowing off Shoal Creek Blvd. In 2025, we successfully hosted our 1st annual Waterwise Landscapes Tour to show Austinites how their neighbors have transformed their yards for water conservation and water quality benefits.

Trail Plan: Exciting Shoal Creek Trail projects now under construction, such as the urban trail along North Lamar Blvd between 29th-31st Streets and the nearly 1-mile-long trail extension connecting the Shoal Creek Trail to the Red Line Trail and Q2 stadium in North Austin. Work continues on the plans and designs for improvements of the Shoal Creek Trail and creek crossing at 3rd Street in downtown Austin and at the location of the 2018 landslide.

Community Engagement: In 2025, we hosted 70 volunteer workdays with over 750 volunteers who removed over 27,000 pounds of litter from Shoal Creek. Volunteers also dispersed native seedballs and planted nearly 800 native plants along the creek.
